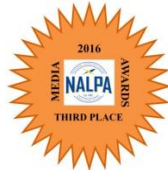

## District 3's Williams resigns from Council

**Surprise, AZ (August 15, 2017)** District 3 Councilmember John Williams on Tuesday, submitted a letter of resignation from the City Council effectively immediately.

Williams was first elected to the City Council in November 2007. He was re-elected last fall to begin a new four-year term January 1, 2017. Williams was elected Vice Mayor by the City Council in 2012 and again in 2015.

Williams noted his decision for resigning in his letter sent to the City Council and City Manager this morning:

"My intention a year ago was to fulfill my obligations as an elected official with four more years of service. Life tends to pivot and shift quickly, often unpredictable, unavoidable, and inconvenient. So while this decision comes very early in my third term and as a surprise to some, it is founded on what is best for my family, my ability to support my family, and how to best serve Surprise and District 3. In stepping down my goal is to refocus all my energy on being the best I can be, as a father, husband and throughout my professional career, never sacrificing the joy in the journey. My hope, I open the door for someone else, someone that reflects the ideals of the working family in District 3 and Surprise, a visionary who will look ahead and serve the greater good for our District and City. Service will never leave me, it's what drove me to seek re-election, and is critical for growing a vibrant and engaged community. So while I will no longer serve in this leadership role, I remain as committed as ever to our community."

"John's sacrifice to service is commendable," says Mayor Sharon Wolcott. "I had the pleasure to serve with him over the past eight years through good times and challenging times for our city and he was a very compassionate leader for Surprise. I recognize the challenges of balancing family, work and service and while I will miss him on the dais, I respect his needing to take more time to devote to family."

Per city code, City Council must formally accept Williams' resignation at a public meeting. As it is not listed on tonight's council agenda, Council will have to take that action at a future meeting.

Because Williams has more than two years remaining on his term, state law requires the city to put the remainder of his term on the next Council election ballot that would be August 2018.

Once Council takes formal action, the City Clerk shall begin the process to advertise for those wishing to apply for the District 3 seat and serve up until the August 2018 election.



The Council interviews each applicant at a public hearing held no later than 10 days following the close of the application acceptance period, followed by a seven-day period during which public comment may be submitted to the City Clerk's Office.

Additional details will be provided by the city once the application process is open.

### **Alert: Surprise 'facility fees' at doctors' offices shock consumers**

Let's say you've been seeing the same doctor for years and you've never had a billing problem. Well, that could change because doctors' offices and their practices are being bought out and that's causing unforeseen problems for consumers, like Elizabeth Edwards.

"I'm recently retired," Edwards said.

Edwards says now that she's retired, she has more time to cook healthy. When it comes to maintaining her health, she tries to see the doctor on a regular basis.

"I called, made sure they took my insurance and everything. I set up an appointment, went and saw this doctor," Edwards said.

Edwards says she went to the doctor's office assigned by her insurance company. Here, she paid her \$5 co-pay mandated by insurance and then had some tests done.

Edwards was then asked to come back a month later for a follow-up visit to get her results.

"The doctor came in and said everything is good, blood work looked fine, you're just one of these people that runs [sic] a low red blood cell count and she says alright, we'll see ya!" Edwards recalled.

Before leaving, Edwards says she paid another \$5 co-pay and thought nothing more of it.

However, she was shocked when she received a bill for \$135. But she was even more shocked at from whom it was, HonorHealth. So, she called.

"Told me, it's a facility fee. It's something they're doing now. Well, I wasn't aware of it. She said we were told the doctor's office was going to send out letters to notify all their patients this was happening. Well, I never got anything," Edwards said.

As it turns out, HonorHealth is gobbling up doctors' offices and one medical practice that HonorHealth bought was Edwards' doctor and when that happens, new billing procedures always occur, including hitting consumers like Edwards with something called a "facility charge."

In Edwards' case, the "facility charge" was \$135 for her follow-up visit.

"Like I said, at a hospital, surgery, that sort of thing I expect it, but not at a doctor's office," Edwards said.

Edwards says HonorHealth told her since they're the new owners, they will be charging patients a "facility charge" for seeing her doctor.

She couldn't believe it so 3 On Your Side got involved. HonorHealth sent us documentation showing Edwards did sign a "financial agreement" when she checked in with her physician. But Edwards thought it was just routine paperwork and had no idea a "facility charge" would be part of her follow-up visit.

Regardless, after 3 On Your Side got involved, HonorHealth told Edwards they would waive the \$135 fee this time.

"If I hadn't called or contacted 3 On Your Side, I wouldn't have gotten this resolution at all, so I am very happy, very pleased," Edwards said.

These facility charges are becoming more and more frequent. So, it's worthwhile to double check with your doctor's office. If you don't, you could get stuck with the hospital's facility fee.

### **Medal of Honor recipient dedicates Vietnam wall at his Legion Post**

James McCloughan, the most recent Medal of Honor recipient, helped dedicate the 49ers Michigan Veterans Memorial Wall at Post 49 in South Haven, Mich., on August 6.



The wall contains the names of the 2,679 Michigan residents who were killed in Vietnam.

"This is quite a reverent day for all of us, especially for those of you in uniform or if you are a family member of someone who made the ultimate sacrifice," said McCloughan, as he read the names of South Haven area Vietnam veterans who were killed. "We are in deep sorrow for our brothers."

While McCloughan is no stranger to public speaking — he coached a Legion Baseball team for 35 summers, plus more than 130 high school sports teams — as a newly minted MoH recipient, he will have more opportunities to engage the public.

"I'd like to give a new image of who the Vietnam veteran is," said the former combat medic who received the medal for his actions that saved at least 10 men. "I just read a book, 'What It's Like to go to war.' In that book, it talks about the Vietnam veteran as being the same as his father who was in World War II. They came home. They started a family. They got into a career. They built their house, as their father did. But you know what? People haven't come to realize that the World War II veteran, like the Vietnam veteran, didn't talk about the war. But the World War II veterans had a lot of people behind them who did talk about the war for them. The Vietnam veterans had no one except for maybe someone who knew what went on over there to speak for them."

McCloughan, a 24-year member of Post 49, joins Korean War veteran Duane Dewey as post members who have received the Medal of Honor.

The Post 49 wall was donated by the Vietnam Veterans of America chapter in Holland, MI. It had been in storage after the VVA group had created a newer one and brought it to Post 49 for an event a year ago.

"I walked in there, saw it and it stopped me dead in my tracks," post adjutant and Vietnam veteran Tom Breen said. "I had the same exact reaction as the first time I saw the Wall in Washington, DC I know the names on that and what they represent."

Breen led a committee that was charged with installing the wall. Before it could be displayed, there were changes to be made as dozens of names were misspelled, damaged or missing. "I'm not going to say it was a pleasurable thing of what those names represented but it was an honor to put those names on the wall and get it put up here," Breen said. "I think we accomplished our mission."

After the ceremony, the 400 or so attendees were broken into smaller groups and escorted into the post's meeting room to view the memorial wall. Visitors paused in hushed tones at the wall, which was illuminated only by

candles. A wreath was placed to honor those who made the ultimate sacrifice.

The impact of the project didn't really hit Breen until he was telling a woman at his local VA about it. "She said, 'Tom, it's kind of like you guys — leave no man behind.' I had never thought of it that way," he said. "But that's what I think of. They're here now, and they are staying. That wall is not going anywhere."

Department of Michigan Commander Brett Holt was among the dozens of Legion Family members from around the state who attended the ceremony.

"For this post to take the opportunity to commemorate and recognize Vietnam veterans is a fantastic thing," Holt said. "It falls in line with exactly what The American Legion is all about — taking care of our veterans and remembering their sacrifice and not allowing the public to forget."

American Legion National Commander Charles E. Schmidt, a fellow Vietnam War veteran, passed along his gratitude in a letter that was read at the ceremony. "I can't tell you how honored I am to know that another of our nation's bravest heroes is also a longtime Legionnaire," Schmidt wrote to McCloughan. "Your heroic service to your country is now permanently etched into history — an inspiration to all Americans."

"Long before President Trump presented you with our nation's highest medal, you inspired countless young people as an American Legion Baseball coach for 35 years. Those players could not have had a better role model and mentor.

"Thank you for all that you have given to your country, your community and The American Legion."



### County names Surprise a satellite voting site for Nov Special Election; sets new onsite voting dates

Surprise City Hall will serve as a Satellite Voting site for this November 7 Special Election cycle.

This designation allows any registered voter residing in Maricopa County to vote or drop-off a ballot at Surprise City Hall- Clerk's Office, during the replacement ballot period and on Election Day.

Due to the designation, the hours for In-Person Replacement Ballot Voting and Ballot drop-off have changed from what was published in the July issue of Surprise Progress Magazine. Here are the following dates/times:

**Saturday October 28 – Tuesday, November 7: In-Person Replacement Ballot Voting period and Ballot Drop-Off.** This includes Saturday and Sunday voting; 8 a.m. – 5 p.m. (\*extended hours on Election Day)

**\*Election Day, Tuesday, November 7: In-Person Voting and Ballot Drop-Off,** 6 a.m. – 7 p.m.

This is a Ballot by Mail Election only. Ballots will be mailed on October 11. In Surprise, registered voters will consider three separate general obligation bond questions requesting bond funding for 10 projects in the areas of **public safety, traffic congestion mitigation and pavement preservation.** The projects include a Public Safety Evidence & Readiness Center, a permanent fire station in north Surprise and a new fire station in the southeast part of the city, road improvements on Waddell, Greenway and Litchfield and a citywide pavement preservation program to fund major road repairs.
